




#### Immunizations for children and teens

#### Updated requirements for bringing dogs into the United States

As of August 1, 2024, the United States (U.S.) Centers for Disease Control and Prevention (CDC) has implemented updated import requirements for all dogs travelling to the U.S. The CDC has different requirements depending on where the dog has been in the 6 months before travelling to the U.S. Please visit the following links for more information:

#### 2nd Annual Ottawa Urban Treaty Day

In collaboration with the <u>Odawa Native Friendship Centre</u>, Indigenous Services Canada will be holding its second annual Ottawa Urban Treaty Day event from September 26-27, 2024.

Urban treaty payment events allow eligible individuals who live in urban areas or are unable to pick up their annuities in their home communities to collect them in person. Everyone is welcome to attend whether they are eligible for treaty payments or would like to participate in festivities which will include vendors, artisans, and service and information booths.

#### Funding opportunity: Green and Inclusive Community Buildings Program

The Department of Housing, Infrastructure and Communities Canada, formerly Infrastructure Canada, is pleased to <u>announce the launch of a third application intake for the Green and Inclusive Community Buildings (GICB) program</u>. The GICB program aims to build new community buildings in areas with populations experiencing higher needs, and improve the quality and resilience of existing buildings, making them more energy efficient and more open and accessible. Please consult the <u>GICB Applicant Guide</u> for full program information.

On April 16, 2024, <u>Budget 2024</u> provided a \$500 million top-up to the existing program and extended it to 2029.

- On **August 1, 2024**, the program began accepting applications for **small and medium retrofit projects**, with total eligible costs ranging from \$100,000 to \$2,999,999.
- On **September 4, 2024**, the program will accept applications for **large retrofit and new build projects**, with total eligible costs ranging from \$3 million to \$25 million.

The deadline to apply under each stream of the program is **October 16, 2024, at 3:00 pm, Eastern Time.** 

If you do not already have an online account with the GICB program, you must complete the <u>Applicant Registration Form</u>. Then, starting on the launch date for your project stream, apply online by logging into the <u>Applicant Portal</u> using your new (or existing) username and password. Please note: The Applicant Portal will only be available on the launch dates for your project streams.

#### **Funding opportunity: Prosecution Pilot**

On the July all-Chiefs call, the Ontario Ministry of the Attorney General and Department of Justice Canada presented on the ongoing Prosecution Pilot. It aims to improve community safety, well-being, and access to justice for First Nations in Ontario by providing funding to interested First Nations to retain private counsel to support the prosecution of First Nation laws.

The Pilot was recently extended and eligible applicants can apply for up to \$35,000 in funding. **Applications will be accepted until December 31, 2024**. #### **Community Story:**

#### New skatepark on Wauzhushk Onigum Nation

Last month, Wauzhushk Onigum Nation (WON) celebrated the grand opening of their new skatepark. On July 23, dozens of community members came out to kick off the summer skate season with a BBQ, beautiful weather, and a great skateboarding show from the local skate shop, Boardanyone. WON purchased skateboards and protective equipment for the youth and partnered with Boardanyone on the day of to help kids learn about skateboarding. The skate shop offered skill lessons on-site, helped the kids choose their own skateboard, and got them properly fitted for safety equipment, like pads and helmets.

The WON Education Department secured funding for a new skatepark and basketball court, while Leadership secured funding for a new play area. The WON Education Team oversaw the creative side of construction, creating and designing the renovated area. Work began in 2021 and construction was completed in 2023. The skatepark was built beside the basketball court, and a new playground was installed to round out the renovations.

COVID-19 surges make it difficult to safely gather indoors with loved ones. The new skatepark provides a beautiful spot where youth and families can play and visit together, without the health stresses of indoor gatherings and travel.
