Home Care Reporting System – HCRS interRAI Contact Assessment (RAI-CA) and interRAI Home Care (RAI-HC)

Five new sites added!

The First Nations and Inuit Health Branch Home Care Reporting System (HCRS) Project in Alberta recently welcomed the following five additional sites, representing seven communities:

- 1. Enoch Cree Nation
- 2. Siksika Nation
- 3. Bigstone Cree Nation

4. Sucker Creek First Nation and

5. North Peace Tribal Council serving the communities of:

- a. Beaver First Nation
- b. Dene Thà First Nation
- c. Tallcree First Nation

These new sites, together with our existing six pilot sites (Blood Tribe, Frog Lake, Woodland Cree, Peerless/Trout Lake, Whitefish Lake and Loon River), make a grand total of thirteen sites in Alberta!

With that, we've been having a busy Fall with training and getting our new sites up and running. So, there will be much more to come in our next update.



Responsibilities of a Custodian

We have been receiving many questions about the responsibilities of a Custodian. So, we have decided to provide an excerpt from the *Act* here.

A custodian must take reasonable steps in accordance with the regulations to maintain administrative, technical and physical safeguards that will (a) protect the confidentiality of health information that is in its custody or under its control and the privacy of the individuals who are the subjects of that information,

(b) protect the confidentiality of health information that is to be stored or used in a jurisdiction outside Alberta or that is to be disclosed by the custodian to a person in a jurisdiction outside Alberta and the privacy of the individuals who are the subjects of that information,

(c) protect against any reasonably anticipated

(i) threat or hazard to the security or integrity of the health

information or of loss of the health information, or (ii) unauthorized use, disclosure or modification of the A. health information or unauthorized access to the health information, and (d) otherwise ensure

compliance with this Act by the custodian and its affiliates.

Note for Pilot Sites: Training for new staff begins with you, now that you're an experienced user of the RAI tools, you have the talent and ability to train new staff, especially the part on demographic information and show new staff the look and feel of the software. New staff will still be required to complete the CIHI on-line module, once that is completed, and you feel more training is needed, please contact our office and we'll be please to assist. Please note: After completing modules, please remember to fax or email a copy of your certificate to our office so that we can update our database.
