# Bulletin to First Nations in Alberta: June 11, 2021

COVID-19 cases continue to decline across the province, as more individuals become vaccinated. The province has moved into the second stage of the <u>Alberta's Open for Summer Plan</u>. This staged plan is dependent on individuals becoming vaccinated and while second doses have started to be administered to individuals in a staged process, there are still individuals who are experiencing vaccine hesitancy and have not received their first dose. Over 67% of eligible individuals have received their first dose across Alberta; while, 48.3% of eligible First Nations on-reserve have received their first dose (for Treaty area breakdown, please see Appendix A, figure 7). Of the 46 First Nation communities in Alberta, 8 communities have vaccinated over 70% of eligible members; 14 communities have vaccinated 50-70% of eligible members; and 24 communities have vaccinated less than 50% of eligible members. Vaccines are our best path forward to easing public health measures. ISC-AB's MOH's are here to support discussions around vaccine hesitancy, provide resources and work with Nations to address any barriers to vaccine uptake. Please reach out to your community liaison team member if you would like to arrange a meeting with a MOH to discuss vaccine hesitancy, so that we can all work together to reducing COVID-19 cases. *Status Update*

Alberta: There are 3,810 Active Cases of COVID-19 in Alberta.

*First Nations living on and off reserve (Alberta):* There are **17,360** confirmed cases of COVID-19 to date and **158** deaths in First Nations living on and off reserve in Alberta. Confirmed cases are: **2,944** in Calgary Zone; **3,943** in Edmonton Zone; **1,424** in South Zone; **5,803** in North Zone; **3,242** in Central zone and **4** unknown. # Testing in Alberta – Update

- As of June 11, 2021, the total number of reported swab samples collected to date in First Nation communities in Alberta is **127,889**.
- **Reminder:** Alberta has launched a <u>rapid testing screening program</u>. Employers, service providers, and interested schools, including those in First Nations communities can <u>apply</u> to the Government of Alberta to receive free rapid test kits for use in their organization.
- Reminder: Testing remains a powerful tool to help limit the spread. If you have symptoms, please stay home and book a testing appointment. #### COVID-19 Vaccine

### COVID-19 Vaccine in First Nations Communities in Alberta as of June 10, 2021

- > 51,770 doses have been administered in 46 Nations (bands) in Alberta
- > 31,002 First Nations people living on reserve have received at least one dose
- > 20,768 First Nations people living on reserve are fully immunized (2 doses)
- > 3,925 First Nations people aged 65 years and older living on reserve have received their first dose.
- > 3,471 First Nations people aged 65 years and older living on reserve are fully immunized (2 doses)

### New Developments

- First Nations health centres have been able to offer second doses to any community member over 12 years of age who has already received a first dose, providing the minimum interval between doses is met. Off-reserve, Alberta is speeding up second-dose appointments and many individuals are now eligible to receive their second dose. Individuals will be able to schedule second-dose appointments for mRNA vaccine (Pfizer/Moderna) in the order they received their first doses. Individuals vaccinated in March and April can currently book their second dose; individuals vaccinated in May can book their second dose on June 28.
- 2. The National Advisory Committee on Immunization (NACI) has updated its recommendation on the <u>interchangeablity of COVID-19 vaccines</u> for second doses following international studies. If an individual received the AstraZeneca vaccine, NACI recommends to receive either the same vaccine or an mRNA vaccine for the second dose. If the first dose was an mRNA vaccine, NACI recommends that the same product be offered for the second dose, and if the same mRNA vaccine is not readily available, then another mRNA vaccine can be considered interchangeable and should be offered as a second dose.
- PHAC is hosting a webinar on June 16, 2021, from 11:30 am to 12:30 pm for Health Care Providers on the NACI Recommendations on COVID-19 Vaccine Interchangeability. This webinar will provide evidence on the interchangeability of COVID-19 vaccines, as well as outline the NACI recommendations for interchangeability. To register please click <u>here</u>.
- 4. Individuals that received an AstraZeneca vaccine will have a choice of booking a second appointment for AstraZeneca by going to the <u>online AHS booking site</u> or calling 811, or they may book a second appointment for a mRNA vaccine through participating pharmacies or AHS. Alberta will have sufficient supply of both types of vaccine to provide second doses. Getting the first vaccine for the first and second dose or a mixed schedule are both considered valid options.

### Reminders

- 1. The Pfizer vaccine can now be stored at regular refrigerated temperatures (2-8°C) at the point of use for up to 31 days. This change will support additional flexibility in vaccine distribution.
- 2. The Government of Alberta has updated the <u>isolation and quarantine requirements</u> for individuals who have been vaccinated.
- 3. All Albertans aged 12 and over are eligible to receive their first vaccine dose. Please contact your local Health Centre for further information on how to receive a vaccine in your community. First Nations individuals living off-reserve can <u>book online</u>, or at a <u>participating pharmacy</u> or call 811.
- 4. Information on vaccinating those aged 12-17 is the same as vaccinating any other age group, with the exception being parental consent is needed. This consent can be written or verbal, but it is important to ensure parents and the child are fully informed on the vaccine and provide one of these forms of consent.

5. Minor and temporary adverse events, such as headache, fever, fatigue, or pain at the injection site, are common after all vaccinations. All individuals are encouraged to seek medical attention if they experience any new or worsening symptoms and to report any adverse events after immunization.

# Alberta's Relaunch - Update

- [New] As of June 10, we are now in Stage 2 of <u>Alberta's Open for Summer Plan</u>. Under this stage, outdoor social gatherings have increased to 20 people with distancing in place, and indoor recreation, entertainment settings and places of worship are open at 1/3 of fire code occupancy. Up to 20 people can attend funeral services or wedding ceremonies (indoors and outdoors) and receptions are permitted outdoors only. COVID-19 transmission will continue to be monitored during each stage and if required, a stage may be paused to respond to trends at regional or provincial levels. These restriction changes apply provincewide and additional details will be released before each stage.
- Reminder: Businesses and non-profits can apply for funding to reduce the cost of hiring and training Albertans for new jobs. Employers can apply for a grant that covers 25 per cent of a new employee's salary for a 52-week period up to a maximum of \$25,000 per employee. Employers have until Aug. 31 to apply. A second intake will open on Sept. 15 and close on Dec. 31. More information can be found at <u>Albert a Jobs Now Program</u>

### **COVID-19 Variants of Concern**

- [New] Alberta has resumed screening all positive cases for variant strains of COVID-19.
- As of June 10<sup>th</sup>, **854** VOCs have been detected in **35** First Nations communities in Alberta. Currently there are **167** active VOCs in **21** First Nations Communities on-reserve in Alberta.
- [New] There is a current COVID-19 outbreak at the Foothills Medical Centre in Calgary that is linked to the more-contagious Delta (India's strain) variant. Out of the 33 individuals linked to this outbreak 10 were fully vaccinated; however, the majority of the cases linked to this outbreak are mild. This variant is being closely monitored to assess if those who are fully vaccinated experience a milder course of the illness as expected. Everyone is strongly encouraged to continue to adhere to public health guidelines.

# What the Government of Canada and ISC/FNIHB-AB Are Doing

- [New] On April 19, Budget 2021 proposed an additional \$760.8 million for the <u>Indigenous Community</u> <u>Support Fund</u> (ICSF). Of this amount, approximately \$200 million will be sent to First Nations, Inuit and Métis Nation communities in the coming days and weeks as direct allocations. A further \$200 million will be sent to First Nations, Inuit and Métis Nation communities in Fall 2021. These funds will be transferred directly to Indigenous communities to provide the flexibility needed to address the specific needs identified by leadership and community members.
- Reminder: <u>Infrastructure Canada</u> is accepting applications for retrofits and new building projects for community buildings. <u>Applications</u> for projects under \$3 million are being accepted on an ongoing basis and applications for projects that are between \$3 million and \$25 million are being accepted until July 6.
- Reminder: Nations that require additional surge supports for COVID-19 response or vaccine clinics including contact tracing, testing, vaccine administration support should submit a <u>request form</u> to ISC-AB at: <u>sac.cdemergenciesab-urgencesmtab.isc@canada.ca</u>.

### Mental Health and Wellness

 Reminder: Mark Amy Treatment Centre is launching a Virtual Addiction Treatment Program from June 14 – July 30. This program is open to all First Nations persons in Alberta, and applications will be accepted until June 7, 2021.  The Alberta Indigenous Virtual Care Clinic (AIVCC) has updated their hours and they are now open until 8:30pm on Wednesdays. 





Fig 1. COVID-19 cases in First Nations communities in Alberta by onset day, June 10, 2021

In general, the number of daily confirmed and probable COVID-19 cases in First Nations communities in Alberta has been increasing since the end of May 2021 (Fig 1).








#### Fig 3. Active COVID-19 cases in First Nations communities in Alberta, June 10, 2021

In general, the number of daily active confirmed and probable COVID-19 cases in First Nations communities in Alberta have been increasing since the beginning of June 2021 (Fig 3).





Individuals between the ages of 10 and 39 years accounted for 52.0% of all cases in First Nations communities in Alberta and 50.6% of all cases in Alberta. Females accounted for 51.3% of all cases in First Nations communities in Alberta and 49.2% among all Albertans.





Fig 5. COVID-19 cases in First Nations communities in Alberta by onset week and VOC status, June 10, 2021



Eight hundred and fifty-four (854) VOCs have been detected and currently there are 167 active VOCs in 21 First Nations Communities making up 65.5% of all active COVID-19 cases in communities.





A total 51,770 COVID-19 vaccine doses have been administered to 31,002 people in First Nations communities in Alberta, of whom 20,768 are fully immunized with two doses.
