Immunization Partnership Fund:

The COVID-19 vaccination campaign is the largest mass vaccination campaign ever undertaken and Canadians have questions and require trusted sources of information. To help in these efforts, the Public Health Agency of Canada (PHAC) is pleased to invite eligible organizations to submit letters of intent (LOI) for projects focussed on increasing Canadians' confidence in and access to COVID-19 vaccines and improving vaccine uptake overall. Addressing Anti-Indigenous Racism in Health Care in Canada:

Minister of Indigenous Services Marc Miller <u>announced last week</u> that the federal government <u>will co-develop the legislation</u> alongside Indigenous leaders and look for "concrete steps" to fight racism that includes giving Indigenous communities the ability to develop and deliver health services. The work ahead will build upon efforts already underway in jurisdictions to ensure that health systems are culturally inclusive, responsive, appropriate, and demonstrate cultural humility. Provinces and territories remain committed to working with local Indigenous communities, organizations, and leadership on this critical issue. Another dialogue will be held in Spring 2021 to pursue discussions related to postsecondary health education, cultural humility training, Indigenous approaches to health, and patient navigation.

Question of the Day

Q: Is there information for those who are worried they need to pay back CERB?

A: On February 9th, the Government clarified that self-employed individuals whose net selfemployment income was less than \$5,000 and who applied for the CERB will not be required to repay the CERB, as long as their gross self-employment income was at least \$5,000 and they met all other eligibility criteria regardless if applied through the Canada Revenue Agency or Service Canada.

Some self-employed individuals whose net selfemployment income was less than \$5,000 may have already voluntarily repaid the CERB. The CRA and Service Canada will return any repaid amounts to these individuals. Additional details will be available in the coming weeks.

REMINDER: Public Health Measures

Alberta is bending the curve to protect our health system, but we must be careful not to lift restrictions too quickly. <u>A</u> <u>Path Forward</u> is a roadmap to help Albertans understand how restrictions will be eased in steps over the coming months. It outlines the sectors that will see gradual restriction changes at each step based on hospitalization benchmarks. Step 1 restriction changes came into effect on Monday.
