# ISC - Alberta Region COVID-19 Update for Chiefs: *June 9<sup>th</sup>*, 2021



## **Updates**

#### **Alberta's Open For Summer Plan:**

In last week's Update, we mentioned the three stage plan for Alberta's Open for Summer mandate, stage two will begin **tomorrow**, **June 10**<sup>th</sup>. This day is two weeks after 60 per cent of Albertans age 12-plus have received at least one dose of vaccine and COVID-19 hospitalizations are below 500 and declining. This following changes to provincial orders include:

- Outdoor social gatherings up to 20 people with distancing (indoor social gatherings still not permitted), Indoor recreation, entertainment and other settings (rec centres, arenas, casinos, cinemas, theatres, museums, galleries, libraries, etc.) – open at 1/3 of fire code occupancy
- Gyms and fitness studios open for solo and drop-in activities and indoor fitness classes with 3 metre distancing
- Funeral services up to 20 people, indoors and outdoors (receptions permitted outdoors only), Wedding ceremonies – up to 20 people, indoors and outdoors (receptions permitted outdoors only)
- Places of worship 1/3 of fire code occupancy
- Personal and wellness services resume walk-in service
- Post-secondary resume in-person learning
- Restaurants 6 people per table max, indoors or outdoors, Retail 1/3 of fire code occupancy (must maintain ability to distance)
- Youth activities (day camps, overnight camps, play centres) resume with restrictions,
  Youth and adult sports resume with no restrictions, indoors and outdoors
- Outdoor public gatherings (concerts/festivals) up to 150 people, Outdoor fixed seating facilities (grandstands) – 1/3 seated capacity
- Work from home order is lifted but still recommended
- Distancing and masking requirements remain in effect

#### **Greener Homes Grant**

Natural Resources Canada is offering up to \$5,600 total for participants in the Canada Greener Homes Grant. This grant helps homeowners make their homes more energy-efficient, through retrofits to their homes such as better insulation. Funding is also available for expert advice to homeowners so they can begin to plan their retrofits. This is also applicable to those in remote communities and those with limited internet access. Additionally, Indigenous governments are encouraged to submit applicants for the <a href="energy advisor recruitment">energy advisor recruitment</a>, training and <a href="mentorship campaign">mentorship campaign</a> to support this initiative and create jobs for evaluators. At least 10% of total funding for this initiative is earmarked Indigenous governments or organizations. Deadline for applying is July 8<sup>th</sup>, 2021.

# Vaccine Update



#### Second Doses in Alberta:

For your off reserve members, the Government of Alberta has specified the scheduling for second doses. Second doses are necessary to ensure that protection lasts as long as possible. Those who are eligible to book their second dose appointment and who consented to be contacted by Alberta Health Services (AHS) when they booked their first dose appointment with AHS, will be notified when it's time to book their second dose appointment. However, Albertans do not need to wait to be contacted to book once they become eligible. For those who did not consent to receive a text message or automated phone call, or if they received their first dose at a pharmacy, can see below for information on when they will be eligible to book. Albertans will be able to schedule second dose appointments in the order they received their first doses:

- Anyone vaccinated in March or earlier can book their second dose starting June 1
- Anyone vaccinated in April can book their second dose starting June 14
- Anyone vaccinated in May can book their second dose starting June 28

Note: Do not book before you are eligible. The appointment will be cancelled.

#### **Importance of Second Doses:**

As First Nations communities continue to take the lead in vaccinations and COVID protection, we must remember that we are not past this pandemic quite yet. New variants such as the "Delta" variant pose legitimate concern as they have been demonstrated to be more transmissible than previous strains of the virus. This variant has been detected in low numbers on reserve in Alberta. Preliminary data released last week from Public Health England suggested that COVID-19 vaccines were effective against the new variant after two doses, but less efficacy was shown with only one dose. NACI statements indicate that one dose of the mRNA vaccines (Pfizer and Moderna) is 60-80% effective against COVID-19, but two doses increase protection over 90%.

# **Vaccine Snapshot**



**49,107** doses of vaccine have been administered in **46** Nations (bands) in Alberta.



At least **29,839** First Nations people have receive their first dose.



At least **3,894** First Nations people aged 65 years and older living on reserve or crown land have received their first dose.



At least **3,415** First Nations people aged 65 years and older have received two doses of the vaccine.



At least **19,268** First Nations people have received two doses of the vaccine.
