Updates

Alberta's Open For Summer Plan:

Alberta's Open for Summer Plan includes three stages based on vaccination thresholds and hospitalizations:

- Stage 1: Two weeks after 50 per cent of Albertans age 12-plus have received at least one dose of vaccine and COVID-19 hospitalizations are below 800 and declining. This includes increased capacity for worship, retail, outdoor dining and outdoor gatherings
- Stage 2: Two weeks after 60 per cent of Albertans age 12-plus have received at least one dose of vaccine and COVID-19 hospitalizations are below 500 and declining. This includes indoor recreation, gym openings, indoor dining, increased capacity at events and retail.
- Stage 3: Two weeks after 70 per cent of Albertans age 12-plus have received at least one dose of vaccine. This includes lifting of all restrictions, including ban on indoor social gatherings. Isolation requirements for confirmed cases of COVID-19 and some protective measures in continuing care settings remain.

Since Alberta reached the 50 per cent threshold for one-dose vaccination on May 18, and with hospitalizations well below 800, **we are currently in Stage 1**. Based on the current pace of vaccinations, Alberta is projected to enter Stage 2 in mid-June and Stage 3 in late June or early July. These are estimates only and rely on all Albertans continuing to drive down our hospitalizations while increasing vaccination numbers. Full details are available <u>here</u>.

ICSF 4:

On April 19, 2021, Budget 2021 proposed an additional \$760.8 million for the Indigenous Community Support Fund (ICSF). The ICSF helps you design and implement community-based solutions to prevent, prepare and respond to the spread of COVID-19 within your communities. These funds can be used for measures including, but not limited to: support for Elders and vulnerable community members, measures to address food insecurity, educational and other support for children, mental health assistance and emergency response services, preparedness measures to prevent the spread of COVID-19. Of this amount, approximately \$200 million is being sent to communities as direct allocations in early June. A further \$200 million will be sent in Fall 2021. These funds provide flexibility to address the specific needs identified by your Nations and members. In addition, \$360 million in needs-based funding will support Indigenous communities and organizations, including \$150 million to support Indigenous peoples living in urban centres and First Nations living off reserve. Question of the Day

Q: Is there support for small businesses needing relief due to COVID-19?

A: Originally launched in April, the **Province reopened the Small and Medium Enterprise Relaunch Grant** program for a new payment to businesses affected by the April 2021 public health orders. Application intake for the spring 2021 payment from Alberta's small business grant has been extended to June 30. The Small and Medium **Enterprise Relaunch Grant (SMERG)** offers financial assistance to Alberta businesses, cooperatives and nonprofit organizations with fewer than 500 employees that have faced restrictions or closures due to COVID-related public health orders, and have experienced revenue losses of at least 30 per cent. Eligible organizations will receive a payment of up to \$10,000, which follows the previous intake that provided up to \$20,000. Funds can be used as business owners see fit. Growing Indigenous tourism in Alberta

As part of the plan to help the tourism sector recover, the Government of Alberta is increasing funding to support Indigenous tourism experiences across the province. As part of this funding, Travel Alberta and Indigenous Tourism Alberta have signed a three-year partnership agreement. This partnership supports reconciliation, Indigenous tourism businesses and helps position Alberta as the premier destination for Indigenous tourism in Canada. Which breaks down as \$1.2 million in 2021-22/\$1.25 million in 2022-23/\$1.3 million in 2023-24. Full details here.

Vaccine Update

Toolkit to Encourage Immunization:

Alberta Health developed a toolkit to help support employers across Alberta as they provide information and encouragement to their employees about getting immunized. The Employer's toolkit for vaccination is intended for use by all Albertans, and we thought you may wish to review it, in case you find any of the materials helpful as you work to encourage your members to be vaccinated as quickly and easily as possible. NACI Advice on Second Dose Mixing:

Yesterday, the National Advisory Committee on Immunization (NACI) updated its recommendations on the interchangeability of COVID-19 vaccines for second doses following studies from Germany, U.K, and Spain.

- If the first dose was the AstraZeneca (COVISHIELD) vaccine, NACI recommends to receive either the same vaccine or an mRNA vaccine (Pfizer-BioNTech, Moderna) for the second dose.
- If the first dose was an mRNA vaccine (Pfizer-BioNTech, Moderna), NACI recommends that the same vaccine product be offered for the second dose.
- If the same mRNA vaccine is not readily available or unknown, another mRNA vaccine can be considered interchangeable and should be offered for the second dose.

In December 2020, Prime Minister Trudeau announced that the Public Health Agency of Canada (PHAC) would establish a pan-Canadian no-fault Vaccine Injury Support Program (VISP), in consultation with provinces and territories. PHAC is pleased to inform you that earlier today, the Vaccine Injury Support Program (VISP) was launched. The VISP is being administered independently by RCGT Consulting. 48,801 doses of vaccine have been administered in **46** Nations (bands) in Alberta.

> At least **28,303** First Nations people have receive their first dose.



At least **3,855** First Nations people aged 65 years and older living on reserve or crown land have received their first dose.



At least **3,361** First Nations people aged 65 years and older have received two doses of the vaccine.



At least **18,427** First Nations people have received two doses of the vaccine.
