Updates

Safe Restart Agreement:

The Government of Canada announced a \$19 billion agreement with all Provinces and Territories. This will address several areas of the economy and public health needs for the next six to eight months such as testing, PPE for front-line workers, child care, mental health, and protecting seniors. While details of how the funding will be distributed are still being worked on we will endeavor to respond to all questions you or your Nations may have and will keep you updated as soon as details are available. This is also a good opportunity to review Alberta's Recovery Plan to see the Province's plan on job creation, safety and build infrastructure.

New Shelter Initiative for Indigenous Women and Children:

Canada Mortgage and Housing Corporation (CMHC), Indigenous Services Canada (ISC) and Crown-Indigenous Relations and Northern Affairs Canada (CIRNAC) have launched an Expression of Interest (EOI) for the creation of 12 new shelters for Indigenous women and children escaping family violence. 10 shelters will be in First Nation communities on-reserve across the country and 2 shelters in the territories (Nunavut, Yukon and Northwest Territories). Fight the COVID Stigma:

Even when taking the necessary precautions, living your daily life can still put any of us at risk of testing positive. Having local access to testing continues to be a priority. Those that come forward for testing, and especially those that test positive, require support in the areas of basic needs (food, isolation supports, mental health, financial, etc.) They also need assurances that heir personal health information will be protected and that testing positive will not worsen existing inequities. We should commit to fight stigma and treat all those affected with kindness. As Dr. Hinshaw said: "When the result of that prompt and transparent action is stigma against their members, it sends a message against transparency and risks discouraging people from being tested or co-operating with public health. All Albertans of every heritage deserve better than that." Discrimination during this pandemic has the potential to harm much more than one person. We are all in this together and must keep working together on our shared goals.

Q: How can we get help to share important health and safety message to members of my Nation?

A: Under the health needs funding stream, you can expense communications related costs. Any reasonable communication support costs could be covered by ISC Alberta Region. These could include print materials to communicate public health measures, electronic message boards to communicate to members during the pandemic or other electronic means of communication.
