#### **Updates**

#### Update on Education Funding:

On August 26, the <u>Government of Canada announced \$2 billion</u>, through the Safe Return to Class Fund, in support for provinces and territories for a safe return to school. An additional investment of \$112 million was also announced to support a safe return for elementary and secondary First Nations schools on reserves. The \$112 million was broken down as follows:

- \$87.5 million for First Nations as a percentage increase to the existing education funding formula,
- \$9.4 million for self-governing First Nations,
- \$3.1 million for Federals Schools and other legal obligations, and
- \$12 million for minor capital support to implement the necessary retrofits following public health guidelines and physical distancing.

The funding will be adjusted the for specific context of First Nations school's size, number of students, grade composition and geography. Indigenous Services Canada is in the process of finalizing allocations and will be distributing the funding directly to your Nations to keep your children safe, based on your specific needs – be it a safe return to classrooms, a transition to an online education model, or a combination of both. In addition to the \$112 million in new funding to support the safe return of First Nations students to school, First Nations are also provided flexible supports through the Indigenous Community Support Fund, which could include costs related to public health measures for reopening schools and other supports for children.

#### **Travel to Communities:**

One of the true joys of our work is the ability to come to your Nations, to meet with you and your members in person to work on our shared priorities. However, safety of your Nation members and our staff must come first, and therefore the department's national restrictions on non-essential travel remain in place. Travel of essential employees continues including those occupying health service delivery and safety positions that are actively engaged in community health service delivery and/or COVID-19 response efforts (e.g. nursing staff, environmental public health officers, emergency response coordinators). Internally, ISC will continue to monitor and establish internal guidelines with input from public health officials to ensure our important work can continue but with a focus on health for both our First Nations partners and our staff . Please be assured, we will continue to keep you apprised of the action and outcomes in the coming weeks and months. We thank you for your understanding and very much look forward to the day where we can meet together again, in-person, in a safe way.

### **Question of the Day**

Q: What happens when a school student or staff member tests positive?

A: As a follow up from our Question of the Day from last week, FNIHB has developed protocols around COVID cases in schools. Attached to this email is an FAQ document about the return to school. This document includes a flow chart to show the process of notification if a case is confirmed at a school. Indigenous Services Canada, First Nations and Inuit Health Branch (FNIHB) Medical Officers of Health (MOH) are informed of positive results directly by the provincial laboratory or AHS Zone MOH. The FNIHB **Communicable Disease Control staff will** then notify the community public health staff at the local Health Centre. The staff member or student (and/or their parent/guardian) is informed of their positive test result, and provided with quidance by community health staff.

The positive case is required to isolate at home. They cannot attend school or attend any public place until public health determines that they are no longer infectious.
